Introduction to the New CySEC's Exams

Based on CySEC's latest <u>Announcement</u>, dated 17/04/2014, the new exams for the certification of persons providing investment services and employed by Cypriot Investment Firms, Credit Institutions, Management Companies and Investment Companies of Variable Capital are planned to take place in September 2014.

On November 9, 2012, pursuant to Law L154(I)/2012, CySEC was appointed as the new authority for conducting the examinations for certification of persons in accordance with the provisions of section 53 of the Investment Services and Activities and Regulated Markets Law of 2007 – 2012 (see relevant <u>Announcement</u>).

Based on the <u>New Framework</u>, two (2) examinations are defined, which will relate to the legal framework on the capital market: The Basic Examination and The Advanced Examination.

Basic Level Examination

Requires basic knowledge of the legal framework on the capital market and concerns persons who wish to be certified only for the provision of the Investment Services of:

- · Reception and transmission of orders in relation to one or more financial instruments
- · Execution of orders on behalf of clients

Advanced Level Examination

Requires a very good knowledge of the Cyprus and European legal framework on the capital markets, and concerns persons who wish to be certified for the provision of all Investment Services:

- · Reception and transmission of orders in relation to one or more Financial Instruments
- · Execution of orders on behalf of clients
- · Dealing on own account
- Portfolio Management
- Investment Advice
- · Underwriting and/or placing of financial instruments whether on a firm commitment basis or not
