The Cyprus Stock Exchange (CSE) organises a Seminar on “*The Stock Exchange Laws for persons interested in being registered as Nominated Advisors*”. The seminar will provide extensive information on the Stock Exchange laws and the Regulatory Decisions of the Stock Exchange Council and is addressed to persons interested in being registered as Nominated Advisors for the Emerging Companies Market of the Stock Exchange or persons employed in companies which already provide services as Nominated Advisors on the CSE.

The seminar will be held on **Thursday, 21 June 2018 at 10:00 a.m. – 13:00 p.m. at the CSE offices (1st floor, Conference Room) in Nicosia. Participation fees are set at €70. The seminar will include a break with snacks.**

The Emerging Companies Market is a Multilateral Trading Facility (MTF) as provided in the Investment Services and Activities and Regulated Markets Law 144(1)/2007. It is managed by the Cyprus Stock Exchange in accordance with its Regulatory Decisions. It is characterised as a “non-regulated” market and does not come under the compulsory provisions that apply to regulated markets. The purpose of the seminar is to explain the role of the Nominated Advisor, their duties, the registration requirements and the relevant supervision as well as the acquisition of knowledge on the Stock Exchange Laws and the Regulatory Decisions of the Council.

The presentation will provide detailed information on the specific Market by CSE executives. More specifically, the following will be presented amongst others:

- a) General features of the CSE Markets / statistics
- b) Conditions and methods of listing on the Regulated Markets
- c) Conditions and methods of listing on the Emerging Companies Market
- d) Information on the ongoing obligation of the issuers
- e) Role / competences and registration procedure for Nominated Advisors
- f) Application for listing on the Emerging Companies Market – Preparation of the Information Document
- g) Central Depository / Central Registry
